## Cookies Policy

### 1. What is a Cookie?

Cookies are usually small text files, given ID tags that are stored on your computer's browser directory or program data subfolders. Cookies are created when you use your browser to visit a website that uses cookies to keep track of your movements within the site, help you resume where you left off, remember your registered login, theme selection, preferences, and other customization functions. The website stores a corresponding file(with same ID tag) to the one they set in your browser and in this file they can track and keep information on your movements within the site and any information you may have voluntarily given while visiting the website, such as email address. ### 2. From where and how do we collect cookies?

We collect cookies across our domain <https://xspot.markets/> and our platform XSpot PRO. The use of the cookies helps us to manage the site and your experience. These cookies may be used to collect analytics of non-personal visitor activity outlines, manage personal preferences, provide relevant or timely information to you or offer focused advertisements.

### 3. For what purposes we collect them?

Cookies set across our site and our trading platform, set by our third-party partners or us, can be in the form of session or persistent cookies, and may use different technologies, such as JavaScript or Flash. If you would like to 'opt out' of the cookies set by our site and trading platforms, this can be accomplished on a cookie-by-cookie basis subject to browser settings. You may limit site operation or functions if you limit the cookies.

### 4. How do we store personal information and for how long?

Cookies are stored in the form of session or persistent cookies, and may use different technologies, such as JavaScript or Flash. According to the ePrivacy Directive, cookies should not last longer than 12 months, but in practice, they could remain on your device much longer if you do not take action.

### 5. How do we obtain your consent and for how long?

We use a special GDPR cookie consent plugin on our website to ensure full compliance with the European Data Protection Regulation. The consent appears to all users and every 12 months, upon the user's first visit to the site, the consent pops up again asking for a renewal of the consent.

### 6. Information on disabling the handling of the cookies' files for the most popular internet browsers:

**For internet browser Internet Explorer 9:** click "Tools" and then "Options" in the browser window; then click the "Privacy" tab and move the slider to the highest position to block all cookies files, or to the lowest position to accept all cookies files; then click "ok".

**For internet browser Internet Mozilla Firefox:** at the top of the Firefox browser window, press the button Firefox (in XP Windows click Menu Tools) and choose “Options”; choose “Privacy” panel; choose from the dropped down menu “Firefox Programme” option “will use settings of the user’s history”; uncheck the function “Accept cookies”; press key “ok”.

**For internet browser Internet Google Chrome:** choose “Settings”; click “Show Advanced Settings”; in section “Privacy”, click “Content Settings”; in section “Cookies files”, click “All cookie files and site data” to open the dialogue window “Cookie files and other data”; choose “Block the attempts to enter the site data into the computer”.

Not making changes of the settings of the internet browser for the settings blocking the writing of the cookies files is equivocal with the granting of consent for their writing.
